# Reports

# **Group Benefits Committee Report**

#### **BERT GORDON**

The Committee met on Wednesday September 17, 2003. Randy Lewis, Blue Cross Representative, was present. We reviewed the claims reports from the time that the new contract started in February. The first three months were quite good, with some increase in May and June. Some surplus has been generated. Membership in the plans continues to grow steadily, with 2464 members participating in one or both plans. This is about 36.5% of our membership. A number of personal claim and membership issues were discussed and clarified. Affected individuals have been contacted. Some points of interest:

- (1) "White fillings" are fully covered for front teeth only. For other teeth they are covered at the same rate as dark fillings.
- (2) The Plan automatically suspends coverage when dependent children reach the age of 21. If older children are in full time attendance at school, the parent(s) must notify the office, in writing, giving the name of the child, the date of birth, and the institution attended.
- (3) Prescription drug costs continue to be our largest expenditure. In the past year about 316 families had claims exceeding \$1000 with one family over \$4000.

Again we encourage people to apply for government assistance under the Prescription Drug Plan. If your family drug costs approach 3.34% (approximately 1/30th) of your family income, assistance may be available under that plan. If in doubt, apply!! Forms can be obtained from any drug store. If you allow the Drug Plan to access your income tax records to obtain your annual income, the application needs to be filed only once and will

remain in effect. If not, a new application must be filed every six months. Our Benefit plans continue to be strong and stable, unlike many other group plans. The STF plan has found it necessary to implement changes, including setting limits on claims in some areas and introducing co-insurance in others. We can maintain our Plans without having to decrease benefits or increase premiums if we continue to accept ownership for our Plans and use them wisely and carefully. Check drug store prices; talk to your doctor about generic drugs; apply for assistance under the Prescription Drug Plan. If we work together we can be successful.

# **Budget and Finance Committee Report**

The committee reviewed the financial statements July and August 31, 2003; recommending approval and acceptance of these reports to the executive.

The current financial state of the association is very positive – income and expenditures are meeting the projected budgetary expectations.

The committee and the executive will be reviewing current guidelines relating to:

a. The STS Contingency Fundb. Expense Allowances

It is good to see the continued membership growth — 6757 to date, with the projected 7000 membership not being too far away. Our approximate 80% membership is the envy of many other associations.

Our answer to their question, "How do you do it?" — Genuine commitment to the Aims of the organization.

#### **ACER/CART Report**

The Twelfth Annual General Meeting of the Canadian Association of Retired Teachers was held in Ottawa on June 20-21, 2003 with representatives from all thirteen provincial retired teachers' organizations in attendance.

The meeting approved a revised statement of Bylaws, Regulations and Policies. One of the changes was in relation to the Executive Committee. It shall be composed of a President and three regional directors, one from Atlantic Canada, one from Quebec and Ontario and one from the West. Val Alcock from Ontario will serve as ACER/CART President for 2003-2004.

After lengthy debate and many discussions, the organization finally approved a per member fee of twenty cents. The Retired Teachers of Newfoundland and Labrador and the Quebec Association of Retired Teachers will need some flexibility in reaching the fee that was set.

The organization continues to struggle to put in place sound administrative and financial procedures and lacks the ability to have the influence that we need at the national level. The reports submitted by the thirteen member organizations of ACER/CART are available on request by any STS member by contacting the STS Office.

#### **Outreach** Report

The last issue of *Outreach*, Volume 25, Number 5- –May/June has been in your hands for some time. This issue covered the 2003 AGM. Again Loretta and Shirley did a wonderful job in getting the information prepared and sent back to Saskatoon. Your Office and Staffing Committee reviewed this draft carefully and it was ready for the final copy within approximately 10 days. However, we experienced a delay at the STF Printing Office

because of other pressing publishing demands, and the actual mail-out was delayed by 4 days because of unexpected demands on the workers at the Ability Council. Consequently, your copy arrived about 1 week later than planned. Sorry about this!

In general, the procedures we have in place for the preparation, publication and distribution of our journal appear to be appropriate and adequate. Our actual printing numbers have increased by about 100 copies over the 6325 of the previous year.

The arrangement of the Office and Staffing committee serving as a pseudo Editorial Committee assures increased accuracy in the copy for distribution. As the chair of *Outreach*, I believe the availability of such an editorial body is essential.

The R.C.M.P. report that 66,352 children were reported missing in Canada in 2003. In Saskatchewan alone, 2114 children were reported missing. According to Child Find, education is key. 

## Something to consider

A corporate attorney sent the following memo to the employees in his company:

The next time you order cheques have only your initials (instead of first name) and last name put on them. If someone takes your cheque book they will not know if you sign your cheques with just your initials or your first name but your bank will know how you sign your cheques.

When you are writing cheques to pay on your credit card accounts, DO NOT put the complete account number on the "For" line. Instead, just put the last four numbers. The credit card company knows the rest of the number and anyone who might be handling your cheque as it passes through all the cheque processing channels won't have access to it. Put your work phone # on your cheques instead of your home phone. If you have a P.O. Box use that instead of your home address.

Never have your Social Security Number printed on your cheques (DUH!). Place the contents of your wallet on a photocopy machine, do both sides of each license, credit card, etc. You will know what you had in your wallet and all of the account numbers and phone numbers to call and cancel. Keep the photocopy in a safe place.

I also carry a photocopy of my passport when I travel either here or abroad. We've all heard horror stories about fraud that's committed on us in stealing a name, address. Social Security number, credit cards, etc. Unfortunately I, an attorney, have firsthand knowledge because my wallet was stolen last month. Within a week, the thieves ordered an expensive monthly cell phone package, applied for a VISA credit card, had a credit line approved to buy a Gateway computer, received a PIN number from DMV to change my driving record information online, and

more. But here's some critical information to limit the damage in case this happens to you or someone you know: We have been told we should cancel our credit cards immediately, but the key is having the toll free numbers and your card numbers handy so you know whom to call. Keep those where you can find them easily.

File a police report immediately in the jurisdiction where it was stolen, this proves to credit providers you were diligent, and is a first step toward an investigation (if there ever is one). But here's what is perhaps most important: (I never even thought to do this). Call the three national credit reporting organizations immediately to place a fraud alert on your name and Social Security number. I had never heard of doing that until advised by a bank that called to tell me an application for credit was made over the Internet in my name. The alert means any company that checks your credit knows your

information was stolen and they have to contact you by phone to authorize new credit. By the time I was advised to do this, almost two weeks after the theft, all the damage had been done. There are records of all the credit checks initiated by the thieves' purchases, none of which I knew about before placing the alert. Since then, no additional damage has been done, and the thieves threw my wallet away this weekend (someone turned it in). It seems to have stopped them in their tracks. The numbers are:
