The STS Provincial Executive convened a Zoom video conference meeting on August 18, 2020, to further consider a number of options regarding the STS 2020 Annual General Meeting that was scheduled for November 2-4, 2020. Legal advice was also received regarding the various options being considered.

Given the continuing situation surrounding COVID-19, the current Saskatchewan Public Health Directives, as well as the lead time required to plan and prepare for an AGM, the Provincial Executive passed a motion to further postpone the STS 2020 AGM until immediately prior to the 2021 AGM scheduled for May 12-14, 2021. Resolutions which have been submitted will be put forth at the 2021 AGM. The 2019-20 Provincial Executive will remain in place until this time. The current budget will also remain in place until the next scheduled AGM as well as the STS membership fee of \$30.00 and Chapter rebate of \$8.00 per member plus \$400.00 per Chapter.

The above information was sent out to all Chapter Presidents in a memo dated August 19, 2020. It is our sincere hope that we will see you all at our 2021 AGM. Future planning will be dependent upon the COVID-19 situation and we will keep you informed regarding our decisions.

Budget, Finance and Audit

The Budget, Finance and Audit Committee met with the auditors from Deloitte on September 21, 2020. The Committee reviewed the audited financial statements for the STS Operating Fund and STS Extended Health Plan for the year ending June 30, 2020. We received a clean audit in both cases with no concerns expressed by the auditors.

Our 2019-20 STS Operating Fund had a surplus of \$410,137. This has been an unusual year and the surplus is largely due to impacts from COVID-19 such as minimal AGM

Advocacy

Despite the COVID-19 lockdown, the Advocacy Committee has been holding meetings via technology (phone, email and Zoom). Our recent focus was on producing materials that would support STS members who wished to engage in discussion with candidates or colleagues in advance of the upcoming provincial election. The production of an election pamphlet has been undertaken by STS for many previous provincial and federal elections. Topics were generated from STS policy and also from issues that have been identified by affiliates such as Saskatchewan Seniors Mechanism and ACER-CART as common for superannuates and older adults. expenses in the current year, reduced *Outreach* expenses due to cancelled issues, reduced office expenses due to delays in technology enhancements, and reduced Executive travel.

The Extended Health and Dental Plan continues to be in a strong financial position with details to be provided in the Group Benefits report. As of June 30, 2020, the Contingency Fund has a balance of \$1,443,965 which represents an increase of \$212,811 from the previous year largely due to earnings in the fund and policy-based transfers.



The budget for the current year will be the last budget approved at the 2019 Annual General Meeting. Our organization continues to be in a strong financial position and the Committee will monitor the current budget as we move through the year.

As of September 21, 2020, our membership was 11,853 which reflects an increase of 142 from last year at this time.

The Committee will review our goals for 2020-21 at our November meeting.

School Board Elections

Elections for School Boards will be occurring on November 9, 2020. Elected school board members serve an important governance function within Saskatchewan's publicly funded education system. One of the fundamental responsibilities of boards is to bring the voice of the public to publicly funded education. Teachers and superannuates have observed and experienced first hand the successes and challenges within the publicly funded education system and have important perspective an to offer. Please be involved in the school board election process by finding out who your candidates are, having conversations about public education with your neighbors and casting your vote on November 9, 2020.

Transition of STS Executive Secretary



As you read this, the Superannuated Teachers of Saskatchewan is being headed up by longtime educator and public figure Murray Wall as the new Executive Secretary.

Perhaps not so strange on the surface, but consider the fact that at the end of June, Fred Herron stepped aside from the position having held the office for two decades. In fact, until his retirement, Herron was the only Executive Secretary in the STS's history.

As the two men sat in the STS office, Herron pointed to Wall, a former President of the Saskatchewan Teachers' Federation from 2003 to 2005, with the unwavering belief that "you can see the STS is in good hands right there," Herron said.

Vividly recalling the interview process, Herron said the clincher for him was "when Murray indicated he was a listener, learner and leader– that's exactly what I wanted to hear," Herron confirmed, acknowledging that earlier he had phoned his would-be successor to contemplate applying for the half-time vacancy. "With his experience and the relationships he has built over the years, Murray is the ideal person for this position," Herron reaffirmed.

Suffice it to say this is a mutual admiration society with Wall maintaining that "it's ideal, and you couldn't ask to step into a better situation with the governance, administration structure and the office staff that is in place. Things are always going to evolve and change, but there isn't anything that I can see where there are any glaring areas that need immediate change."

Wall indicated the transition will be that much easier in that he has had a six-month mentoring period. He praised the STS for having that kind of insight.

"I've tried hard to absorb as much as I could and this is a great opportunity for me to stay involved in education," said Wall, who in addition to a lengthy teaching career, also spent a decade as a senior administrative staff member with the STF.

"The time commitment is about right and the more I thought about this and reflected on it, everything seemed right and there were no kinds of red flags. I know the organization [STS] has a strong reputation and is valued. I've always been aware of the strong sense of involvement and commitment the STS has demonstrated so I'm looking forward to my involvement," Wall added.

Reflecting back on his time in the position, Herron recalled how things were not quite so rosy when he assumed the role, citing the fact the organization was mired in a very dire financial situation with membership on the decline while premiums were on the rise and the health and dental plan was in need of an overhaul.

The latter was ultimately much improved thanks to the work of a committee of STS and with help from the STF – eventually Saskatchewan Blue Cross became the new provider. Today, Herron said the organization's finances are in an extremely strong financial position with 11,700 members. He noted that among provinces with self-funded plans, the STS is able to provide equal or better coverage with considerably lower premiums than other jurisdictions in the country.

Aside from those more tangible gains made during Herron's tenure, Wall also pointed to the valuable aspects of being an STS member, particularly in terms of the social aspect and the ability for retired teachers to remain involved.

"Retired teachers will have an opportunity to be involved in the profession and this organization gives them advocacy and a chance to have their voices heard when it comes to issues that are important to them, and when you look at the pre-retirement lifestyle seminars as an example of how this organization helps assist in the transition for some folks. It's a very vibrant organization."

Both attributed that in large part to the invaluable work of the three-member administrative office staff.

"I can tell you what has strongly impressed me in the time I've been here is how well members' requests and questions are answered in a thoroughly professional, respectful manner–and believe me we get a lot of calls," Wall noted.

Herron was equally effusive, adding that "Probably the most important part of making this work is the dedicated people we are lucky enough to have here. From my point of view, that has been just tremendous. Yes, the buck stops here, but in the vast majority of cases I just got out of the way and let the staff do their job because they do it so well."

While he said it's just the right time to catch his breath, "I'm going to miss the people, but I'm leaving in peace and I know everything is where it should be."

If somewhat reluctant to sing his own praises, Herron, always the historian, pointed to one of the many key decisions made by the venerable Dr. Stirling McDowell who was the one who advocated for the STS to have its own Executive Secretary.

"It's just another example of his contributions and how his hand [McDowell] is still on the history of this organization–and that of the STF," Herron emphasized.

Group Benefits

The audited financial statement for the STS Extended Health Fund as of June 30, 2020, showed an increase in the assets of the Plan of approximately \$4.2M with all reserves full. This was the second year of the contract with Saskatchewan Blue Cross and the Plan is in a strong financial position.

Bob Wilhelms (Saskatchewan Blue Cross Representative) met with the Committee and reviewed the Health and Dental Experience Report for the STS Benefits Plan as well as the Analysis of Expenses for the 12 months from September 1, 2019 to August 31, 2020. Health revenue was approximately \$10.4M and expenses approximately \$7.8M for a surplus of approximately \$2.5M. Dental revenue was approximately \$6.2M and expenses approximately \$4.6M with a surplus of almost \$1.6M.

The first two months of the third year (July 1, 2020 – August 31, 2020) of the contract with Saskatchewan Blue Cross showed approximately \$1.78M health revenue and approximately \$1.3M expenses for a surplus of approximately \$433,000. Dental revenue over the same period was approximately \$1.07M and expenses approximately \$890,000 for a surplus of approximately \$136,000. Overall surplus for the Benefits Plan for the two months is approximately \$569,000. The surplus is higher than expected due to the effect of COVID-19 as there were fewer member claims for benefits such as paramedical services and regularly scheduled dentist visits. Drug claims remained relatively constant. It is uncertain how the Plan will be impacted going forward.

Plan members will receive more information about the Plan and travel coverages as it becomes available. Members are encouraged to use the Blue Cross mobile app as it provides information regarding drugs covered, prompt adjudication of claims, and online deposit of payment as well as other pertinent information regarding the Plan. At present, Saskatchewan Blue Cross is hoping to open their offices in Regina and Saskatoon for customers on October 13, 2020.

Membership in one or both portions the STS Plan as of October 1, 2020, was 8,359, an increase of 216 from March 1, 2020.

We hope everyone is being careful and keeping healthy.

They were later stationed in North Battleford for the duration of the war. After the war, Dinnis got a job teaching at Fox Hills, Saskatchewan. They spent five years there and then moved to Jasmin. After Jasmin the family moved to Leross. Fran was hired by Dr. Spinks as his secretary and worked in the office of the President of the University of Saskatchewan. After a sabbatical the family returned to Leross and then moved to Wadena.

In Wadena, Fran was a homemaker until her youngest child went to school at which time she was hired by the local law office and worked there for twenty-five years. Fran was involved with the local curling club and was a founding member of the local arts council. In addition to this she kept involved with church meetings, parish council and the Catholic Women's League.

When Dinnis passed away in 1969, Fran, as a surviving spouse, was eligible to become a member of the STS. She

Seasonal allergies in a time of COVID-19

Many of the symptoms of seasonal allergies and COVID-19 are similar. Cough, headache and/or a sore throat are just a few symptoms that belong to both. If you are typically affected by seasonal allergies at this time of year, you likely have a go-to medication you take to improve your symptoms. If this medication does not work on your symptoms as it usually does, in the timeframe it usually does, you should stay home and arrange for a COVID-19 test by calling HealthLine 811 or your primary healthcare provider.

Other tips for helping with seasonal allergies include reducing your exposure to allergy triggers. This can mean staying indoors on dry, windy days, delegating lawn mowing and other gardening chores to someone else, having a shower after being outdoors and washing those clothes, closing windows at night, using high-efficiency filters in your furnace, and vacuuming often.

If you are approved by the Seniors' Drug Plan, you will receive a confirmation letter from the Ministry of Health. STS Group Benefit Planholders who are eligible for the Saskatchewan Seniors' Drug Plan may be eligible for a reduced premium by providing the STS Office with a copy of the Seniors' Drug Plan confirmation letter.


is available online, which is usually a week earlier than receiving the paper copy. There are presently 1,919 members receiving *Outreach* online.
